

**License Agreement for
the right to use a scientific work in the journal**

hereinafter referred to individually or jointly as the "Author (Co-authors)", on the one hand, and the Editor-in-Chief of the journal "Humanitarian Sciences in Siberia»,

Shelegina Olga Nikolaevna

(full name)

acting on behalf of the Editor (Founder) of the journal, hereinafter referred to as the "Editor", on the other hand, have concluded this agreement as follows.

1. Subject of the Agreement:

1.1. The author grants the Editor exclusive license to use scientific works (hereinafter – Article) created by the Author (Authors), free of charge, for the duration of copyright provided by the Russian Federation current legislation

(the Article title)

published in the journal "Humanitarian Sciences in Siberia" (hereinafter - the Journal), within the frames defined by this Agreement without reserving the Author (Co-Authors) the right to issue similar licenses for this Article to other persons.

1.2. The rights transferred under this Agreement include:

- reproduction of the Article or its separate part in any material form including paper and electronic copies in the form of a separate work, as a part of the Journal(s) and/or in the databases of the Editor and/or other persons, at the discretion of the Editor and/or Founder of the Journal;
- bringing the Article or its separate part to the public with the possibility for any person to access the Article from any place and at any time of their own choice (including the Internet);
- public display of copies of the Article or its separate part;
- processing, including the translation of the Article (including into English), and using the revised (translated) Articles in the above ways;
- sublicensing (granting the rights to use the Article and its individual parts obtained under this Agreement to third parties).

1.3. The territory, where the rights specified in paragraphs 1.1 and 1.2 of this Agreement apply, covers the territory of all states where copyright is protected by international treaties of the Russian Federation or on other grounds.

1.4. The Parties have agreed to extend the validity of this Agreement to the previously established relations starting from the moment of submitting the Article to the Journal.

2. The Author (Co-authors) guarantees:

2.1. He (they) is the actual copyright holder(s) of the exclusive rights to the Article; the rights granted to the Editor under this Agreement have not been transferred to him (them) before and will not be transferred to third parties in the future;

2.2. The Article is an original work, has not been submitted to consider and has not been previously published in other printed and (or) electronic editions, except for the publication of an Article preprint (manuscript) of Authors (Co-authors) on their own website, the Article is not a "commissioned" or official work;

2.3. The article contains all the references provided by the current legislation to the cited authors and published sources of borrowed materials, the Author (Co-authors) received all the necessary permissions to use materials in the Article, which copyright holder(s) is (are) not the Author (Co-Authors);

2.4. The article does not contain materials that are not subject to be published in the open press according with the current legislative acts of the Russian Federation.

3. Rights and responsibilities of the Author (Co-authors):

3.1. The Author undertakes:

3.1. Not to publish the Article in other printed and (or) electronic editions, and not to distribute it without the Editor consent;

3.1.2. To use an electronic copy of the Article prepared by the Publisher and transmitted to the Author exclusively in accordance with the terms of this Agreement.

3.2. The Author (Co-authors) has the right to:

3.2.1. Use printed or electronic preprints of the Article manuscript. Such preprints may be posted as electronic files on the Author's (Co-Authors') website, or on a secure external website of the Author's (Co-Authors') employer, but not for systematic external distribution to others. At the same time, the Author (Co-authors) must include the following warning in the preprint: "This is the preprint of the Article accepted for publication in (Journal title, (C), copyright (year), copyright owner specified in the Journal)".

3.2.2. Photocopy or transfer free to colleagues a copy of the printed Article in whole or in parts for their personal or professional use, to promote academic, research, or informational purposes.

3.2.3. Use separate materials from the published Article in the book written by the Author (Co-authors).

3.2.4. Include the Article materials in educational collections for using at classes, distribute the materials of the Author (Co-authors) among students free of charge, save the materials as a part of the training course in electronic format on a local server for students to access, and apply them for internal training programs in the employer's institution, but not for systematic distribution or free access.

4. The Publisher undertakes:

4.1. To provide scientific, literary, artistic and technical editing of the Article, production and (or) processing of illustrative material, production of paper and electronic original layout, reproduction and distribution of the Article in paper and/or electronic form in accordance with the terms of this Agreement and the publication schedule of the Journal at its own expense.

5. The publisher has the right to:

5.1. Demand specified persons indicating (link) to the Journal, the Publisher or copyright

holder of the Journal, the Author (Authors) or other holders of copyright, title, volume, issue and year of publication specified in (on) the Journal for any use by the Author (Co-authors) (and/or other persons) the Article (including any of its part, fragment)

5.2. Establish the rules (conditions) for the acceptance and publication of materials in the Journal.

5.3. Use the Article at its own discretion in any way, within the frames of the rights obtained under this Agreement.

6. The Agreement other terms:

6.1. In accordance with the Civil Code of the Russian Federation (Article 1269), the Author (Co-authors) have the right to refuse a previously made decision on publication (reproduction) Articles (right to recall) compensating the Editor losses caused by such a decision. If the Article is published, the Author (Co-authors) are also obliged to notify publicly about its withdrawal. At the same time, the Author (Co-authors) has the right to withdraw from circulation previously issued copies of the Article, the Journal, reimbursing the losses caused for the Editor and third parties (subscribers).

6.2. In case of requirements (claims, lawsuits) submitted to the Editor by third parties related to the violation of exclusive copyright and/or other intellectual property rights when using the Article by the Publisher, the Author undertakes:

– immediately after receiving the Editor's notification, to take measures to resolve disputes with third parties, if necessary, enter the legal process on the Editor's side and take all actions in its power to exclude the Editor from the list of defendants;

– to compensate for the Editor the legal costs and losses incurred by the Editor to a third party in connection with the violation of copyright and other intellectual rights.

6.3. Everything is not directly regulated by this Agreement is subject to settlement in accordance with the current legislation of the Russian Federation, the rules (conditions) for accepting and publishing materials in the Journal (Authors' Guidance)
